Held January 6, 2010

### **Financial Legislation – Scott Garrett**

Mr. Garrett read Ordinance O-2010-1 **BEING AN ORDINANCE AUTHORIZING TRANSFERS AND APPROPRIATIONS FOR THE VILLAGE OF WINDHAM AS SET FORTH BELOW AND DECLARING AN EMERGENCY** and made a motion to suspend the rules which was seconded by Mr. Snyder. Vote of Council: Ayes: Mrs. Barrett, Mr. Garrett, Mrs. Meszaros, Mrs. Miranda, Mrs. Rininger, Mr. Snyder. Nays: None. Motion carried.

Mr. Snyder then made a motion to adopt Ordinance O-2010-1 which was seconded by Mrs. Meszaros. Vote of Council: Ayes: Mrs. Barrett, Mr. Garrett, Mrs. Meszaros, Mrs. Miranda, Mrs. Rininger, Mr. Snyder. Nays: None. Motion carried.

Mr. Garrett read Ordinance O-2010-2 **AN ORDINANCE APPROVING AND ADOPTING AN AMENDMENT TO THE PERMANENT APPROPRIATIONS FOR 2009 FOR THE VILLAGE OF WINDHAM, CALLED FOR IN THAT BUDGET, AND DECLARING AN EMERGENCY.** Mr. Snyder made a motion to suspend the rules which was seconded by Mr. Garrett. Vote of Council: Ayes: Mrs. Barrett, Mr. Garrett, Mrs. Meszaros, Mrs. Miranda, Mrs. Rininger, Mr. Snyder. Nays: None. Motion carried.

Mr. Snyder then made a motion to adopt Ordinance O-2010-2 which was seconded by Mr. Garrett. Vote of Council: Ayes: Mrs. Barrett, Mr. Garrett, Mrs. Meszaros, Mrs. Miranda, Mrs. Rininger, Mr. Snyder. Nays: None. Motion carried.

#### **Safety, Personnel and Rules**

Mr. Snyder read Resolution R-2010-1 **A RESOLUTION AUTHORIZING A CONTRACT BETWEEN THE VILLAGE OF WINDHAM AND WINDHAM TOWNSHIP FOR THE PROVISION OF FIRE PROTECTION SERVICES AND DECLARING AN EMERGENCY** and made a motion to suspend the rules which was seconded by Mr. Garrett. Before the roll of Council was taken it was decided to table this legislation until January 26, 2010 at the Regular Council Meeting so everyone would have additional time to review the legislation. This was also under the advice of Solicitor Tom Reitz.

Mr. Garrett made a motion to adjourn the meeting which was seconded by Mrs. Meszaros. Vote of Council: Ayes: Mrs. Barrett, Mr. Garrett, Mrs. Meszaros, Mrs. Miranda, Mrs. Rininger, Mr. Snyder. Nays: None. Motion carried and Council was adjourned at 6:25 PM.
