

RESOLUTION NO. R2007-12

A RESOLUTION AUTHORIZING BALLFIELD NUMBER 1 IN WINDHAM VILLAGE PARK TO BE NAMED "JEFF STANLEY FIELD" IN HONOR OF JEFF STANLEY A LIFE-LONG RESIDENT OF WINDHAM AND EXTRAORDINARY MAN WHO SPENT COUNTLESS HOURS IN OUR SCHOOLS AND PARK DEDICATED TO TEACHING YOUNGSTERS ABOUT SPORTS AND LIFE.

WHEREAS, Jeff Stanley during his tenure with Windham Hot Stove spent countless hours on our Park Ball Fields dragging and lining the ball field, landscaping the fields, designing and building to make the ball diamonds a better place for our youth; and

WHEREAS, Jeff was instrumental in getting dugouts, homerun fences and concession stands in the Park which helped draw tournaments to our Village; and

WHEREAS, Jeff was a Windham Hot Stove Baseball/Softball Manager for 14 Seasons spanning 16 years (1987-2003), 11 of which he was simultaneously serving as an assistant coach for another team; and

WHEREAS, as Manager, Jeff never had a losing Season and led his teams to 3 State Championship Titles, 3 State Runner-up Titles, 2 Regional Titles, 8 District Championships, and 9 League Titles; and

WHEREAS, Jeff served on the Windham Hot Stove Baseball and Softball Board for 18 years and initiated the Windham Hot Stove Web Site as well as the Windham High School's Sports Website; and

WHEREAS, Jeff Stanley is very worthy of this honor; and

WHEREAS, the Village Park Committee has met and discussed this matter and recommends approval ; and

WHEREAS, the Council of the Village of Windham wishes to name Village Park ballfield number 1 in honor of Jeff Stanley;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Windham two-thirds or more of the members elected thereto concurring that:

Section One: That Windham Village Council approve Ball Field Number 1 in the Village Park to be named in honor of Jeff Stanley

Section Two: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

Section Three: This Resolution is hereby declared to be an emergency measure necessary to preserve the public health, safety, morals and general welfare of the inhabitants of the

Village of Windham, Ohio and this Resolution shall go into full force and effect immediately upon its passage by three-fourths (3/4's) of the members of Council.
