RESOLUTION NO. R-2009-22

A RESOLUTION CONFIRMING VARIOUS EMPLOYEES WITHIN THE VILLAGE OF  
WINDHAM FIRE DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, the Village of Windham is a party to litigation known as the Village of Windham, et al., vs. Windham Township, et al., Case No. 2007 CV 1774, presently pending in the Portage County Common Pleas court. The controversy involved in the pending litigation is the ownership of the Windham Village Fire Department; and

WHEREAS, barring an agreed upon settlement prior to July 1, 2009, the Village of Windham must be in the position to operate the Village of Windham Fire Department commencing on July 1, 2009; and

WHEREAS, the Council of the Village of Windham desires to confirm the employment of the individuals who have previously served both the Village of Windham and Windham Township in the Village of Windham Fire Department through this legislation.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Windham, Portage County, Ohio, two thirds or more of the members thereto concurring that:

Section 1: The Council of the Village of Windham hereby confirms and ratifies the employment of the following members of the Village of Windham Fire Department:
