A RESOLUTION AUTHORIZING THE VILLAGE FISCAL OFFICER OF THE VILLAGE OF WINDHAM TO CREATE A THEN AND NOW PURCHASE ORDER NUMBER 426-2008 TO AGRI SLUDGE, INC. IN THE AMOUNT OF \$4400.00 FOR HAULING SLUDGE ON APRIL 4, 2008 AND DECLARING AN EMERGENCY.

**WHEREAS**, the Council of the Village of Windham desires to properly maintain the Sewer Plant; and

**WHEREAS**, there was an service performed for which a purchase order had not been created prior to the service and the cost of the service exceeded \$3000.00 which makes passage of this Resolution necessary for the Then-And-Now Purchase Order to be created and the invoice to be paid; and
