A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Windham, Portage County, Ohio in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2009; and

WHEREAS, the Budget Commission of Portage County, Ohio, has certified its action thereon to the Council of the Village of Windham together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill tax limitation;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Windham, three-fourths or more of the members elected thereto concurring that:

Section One: That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

Section Two: That there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation as follows in Schedule A and Schedule B.

Section Three: That the Clerk of this Council be, and is hereby directed to certify a copy of this Resolution to the County Auditor of said County.
