A RESOLUTION AUTHORIZING THE VILLAGE FISCAL OFFICER OF THE VILLAGE OF WINDHAM UNDER SECTION 735.29 OF THE OHIO REVISED CODE TO CERTIFY THE FOLLOWING SUMS TO THE PORTAGE COUNTY AUDITOR TO BE ASSESSED AND COLLECTED AS DELINQUENT WATER/SEWER RENTS TOTALING \$32,901.93 AS SET FORTH HEREIN AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Windham desires to collect these delinquent water/sewer rents; and

WHEREAS, there was water/sewer rents received by the parcel owners that went unpaid; and

WHEREAS, this matter is an emergency affecting the health, safety, and welfare of the residents of the Village of Windham.

NOW THEREFORE, be it resolved by the Council of the Village of Windham, three-fourths or more of its elected members concur that:

<u>Section One:</u> The Village Fiscal Officer shall have the authority to under section 735.29 of the Ohio Revised Code to certify sums to the Portage County Auditor to be assessed and collected as delinquent water/sewer rents totaling \$32,901.93 as set forth herein;
