

RESOLUTION R-2006-11

A RESOLUTION APPOINTING EDWARD M. PERDIAN AS INTERIM CHIEF OF POLICE OF THE VILLAGE OF WINDHAM ON A VOLUNTARY BASIS FROM NOVEMBER 20, 2006 UNTIL FEBRUARY 15, 2007, WHEN EDWARD M. PERDIAN SHALL BECOME CHIEF OF POLICE OF THE VILLAGE OF WINDHAM AND THE SIX (6) MONTH PROBATIONARY PERIOD SHALL COMMENCE AFTER WHICH COUNCIL AGREES TO WAIVE THE RESIDENCY REQUIREMENT SET FORTH IN THE OHIO REVISED CODE AT HIS CURRENT RESIDENCE DECLARING AN EMERGENCY AND REPEALING ALL PRIOR INCONSISTANT ORDINANCES.

WHEREAS, the Village of Windham’s Safety, Personnel, and Rules Committee has assisted the Mayor with interviews and the Mayor recommends Edward M. Perdian for Chief of Police, and

WHEREAS, Edward M. Perdian has agreed to serve the Village of Windham from November 20, 2006 to February 15, 2007 on a voluntary basis due to prior commitments, and

WHEREAS, the Village Council agrees to waive the residency requirement at his current address upon satisfactory completion of the six (6) month probationary period which shall commence February 15, 2007 and

WHEREAS, this matter is an emergency affecting the health, safety and welfare of the residents of the Village of Windham;

NOW, THEREFORE, BE IT RESOLVED, by Council of the Village of Windham, three-fourths or more of the members elected thereto concurring that:

Section One: That Council hereby approves the Mayors appointment of Edward M. Perdian as Interim Chief of Police of the Village of Windham on a voluntary basis from November 20, 2006 until February 15, 2007 at which time he shall become Chief of Police and commence a six (6) month probationary period after which Council agrees to remove the residency requirement as set forth in the Ohio Revised Code.

Section Two: It is hereby determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

Section Three: This Resolution is hereby declared to be an emergency measure necessary to Preserve the public health, safety, morals and general welfare of the inhabitants of the Village of Windham, Ohio and this Resolution shall go into full force and effect immediately upon its passage by three-fourths (3/4’s) of the members of Council.
