

**ORDINANCE NO. O-2009-27**

**AN ORDINANCE ESTABLISHING THE RATES TO BE CHARGED THE FIRE AND EMERGENCY MEDICAL SERVICES FEES AND DECLARING AND EMERGENCY**

**WHEREAS**, the Council of the Village of Windham has determined that it is necessary to establish rates to be charged for various services rendered by the Village of Windham Fire Department.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Windham, Portage County, Ohio two thirds or more of the members thereto concurring that:

**SECTION 1:** The hourly rates for the years 2009 through 2013 are hereby established as is set forth on the attached Exhibit "A" marked for identification and incorporated herein by reference.

**SECTION 2:** This Ordinance is declared to be an emergency measure, effectively immediately upon its passage by Council and approved by the Mayor, for the reason that it is necessary to preserve the health, safety and general welfare of the Village and to immediately establish the rates set forth in Section 1 of this Ordinance in that it is likely that the Village of Windham Fire Department will be called upon to provide fire services and emergency medical services to areas outside of the Village in the near future.

**SECTION 3:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.
