

**ORDINANCE NO. 0-2008-8**

BEING AN ORDINANCE AUTHORIZING TRANSFERS AND APPROPRIATIONS FOR THE VILLAGE OF WINDHAM AS SET FORTH BELOW AND DECLARING AN EMERGENCY.

**WHEREAS**, the Mayor and Finance Committee have recommended to Council that the following transfer and appropriations be made; and

**WHEREAS**, the Council of the Village of Windham declares this an emergency measure for the health, welfare and safety of the residents of the Village of Windham;

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Windham three-fourths or more of the members elected thereto concurring that:

**Section 1:** That the sum of \$3000.00 be, and hereby is transferred and appropriated within the Sewer Operating Fund as follows:

\$3000.00 from Other – Supplies and Materials # 5201-549-490-0000 to Natural Gas # 5201-591-313-0000 retroactively to March 25, 2008.

That the sum of \$36.00 be, and hereby is transferred and appropriated within the Sewer Operating Fund as follows:

\$36.00 from Other – Repairs and Maintenance REPAIR/REPLACEMENT # 5201-549-439-0060 to Small Tools and Minor Equipment # 5201-549-440-0000 retroactively to March 25, 2008.

**Section 2:** That the sum of \$1000.00 be, and hereby is transferred and appropriated within the General Fund as follows:

\$1000.00 from Telephone # 1000-110-321-0000 to Other – Professional and Technical Services # 1000-110-349-0000 retroactively to March 31, 2008.

That the sum of \$1200.00 be, and hereby is transferred and appropriated within the General Fund as follows:

\$1200.00 from Other Income Tax Refund # 1000-755-600-0110 to Deposits Refunded # 1000-760-610-0000 retroactively to April 3, 2008.

**Section 3:** That the sum of \$100.00 be, and hereby is transferred and appropriated within the State Highway Fund as follows:

\$100.00 from Other – Supplies and Materials # 2021-620-490-0000 to Advances – Out # 2021-920-920-0000 retroactively to March 31, 2008.

**Section 4:** That the sum of \$13.00 be, and hereby is transferred and appropriated within the Street Construction Maintenance & Repair Fund as follows:

\$13.00 from Uniforms and Clothing # 2011-610-270-0000 to Other – Supplies and Materials # 2011-620-490-0000 retroactively to April 18, 2008.

That the sum of \$5,000.00 be, and hereby is transferred and appropriated within the Street Construction Maintenance & Repair Fund as follows:

\$5000.00 from Salaries - Council SALARY STREETS # 2011-620-111-0170 to Workers Compensation 2011-620-225-0000 retroactively to April 16, 2008.

**Section 5:** That the sum of \$8000.00 be, and hereby is transferred and appropriated within the Water Operating Fund as follows:

\$8000.00 from Other – Supplies and Materials # 5101-533-490-0000 to Workers' Compensation # 5101-531-225-0000 retroactively to April 18, 2008.

**Section 6:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**Section 7:** This Ordinance be declared an emergency measure and become effective upon its passage by Council and approved by the Mayor, and to further insure the health, safety and welfare of the residents of the Village of Windham.
