

**ORDINANCE NO. O-2007-6**

AN ORDINANCE AUTHORIZING THE MAYOR AND VILLAGE FISCAL OFFICER OF THE VILLAGE OF WINDHAM TO ENTER INTO A CONTRACT WITH THE BOARD OF EDUCATION OF THE WINDHAM EXEMPTED VILLAGE LOCAL SCHOOL DISTRICT FOR A PARCEL OF LAND BEHIND THE CURRENT MUNICIPAL BUILDING FOR A PARKING LOT DECLARING AN EMERGENCY AND REPEALING ALL PRIOR INCONSISTENT ORDINANCES.

**WHEREAS**, the Village Properties Committee and Finance Committee have recommended to Village Council that additional parking would be an asset to the Village, Library, Community Building and for other uses; and

**WHEREAS**, the Board of Education of the Windham Exempted Village Local School District has agreed to lease some of their land to the Village of Windham for creating a parking lot on said area; and

**WHEREAS**, this matter is an emergency measure affecting the health, safety and general welfare of the residence of the Village of Windham;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Windham three-fourths or more of the members elected thereto concurring that:

**Section One:** That the Mayor and Village Fiscal Officer of the Village of Windham are hereby authorized to enter into a contract with the Board of Education of the Windham Exempted Village Local School District for the parcel of land behind the municipal building for the purpose of creating a parking area to serve the municipal building, library, community center and the public in general.

**Section Two:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**Section Three:** This Ordinance is hereby declared to be an emergency measure necessary to preserve the public health, safety, morals and general welfare of the inhabitants of the Village of Windham, Ohio and this Ordinance shall go into full force and effect immediately upon its passage by three-fourths of the members of Council.
