

ORDINANCE NO. O-2013-26

BEING AN ORDINANCE AUTHORIZING TRANSFERS AND APPROPRIATIONS FOR THE VILLAGE OF WINDHAM AS SET FORTH BELOW AND DECLARING AN EMERGENCY.

WHEREAS, the Mayor and Finance Committee have recommended to Council that the following transfers and appropriations be made, and
