

ORDINANCE NO. O-2010-20

**AN ORDINANCE ACKNOWLEDGING THE ACCEPTANCE OF SNOW ROAD
AS A VILLAGE ROAD, IN CONFORMITY WITH ANNEXATION
PROCEEDINGS WHICH TOOK PLACE IN 1958 AND 1959**

WHEREAS, issues have arisen which call into question whether Snow Road is a road accepted as a dedicated road of the Village of Windham; and

WHEREAS, various interested parties have undertaken research to determine whether Snow Road is a road accepted for dedication by the Village of Windham; and

WHEREAS, the research has resulted in conclusive evidence that Snow Road was accepted for dedication as a part of the annexation proceedings which took place in the later months of 1958 and being completed in the earlier months of 1959.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Windham, State of Ohio, a majority or more of the members thereto concurring that:

SECTION 1. The twelve pages of documents attached hereto and marked for identification as Exhibit "A" are accepted as part of the official records of the Village of Windham.

SECTION 2. That the road known as Snow Road was part of the annexation proceedings which are set forth in the attached Exhibit "A", and Snow Road was accepted for dedication as a public road by the Village of Windham in 1959.

SECTION 3. All actions taken by the administration of the Village of Windham since February 1959 with respect to Snow Road, which actions treated Snow Road as a dedicated road of the Village of Windham are hereby ratified.

SECTION 4. It is hereby declared that from this time forward, in order to remove any ambiguity which may exist, that Snow Road is a public road, offered to and accepted by the Village of Windham.

SECTION 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.
