

RESOLUTION R-2019-14

A RESOLUTION AUTHORIZING THE VILLAGE FISCAL OFFICER OF THE VILLAGE OF WINDHAM UNDER SECTION 715.261 OF THE OHIO REVISED CODE TO CERTIFY THE FOLLOWING SUMS TO THE PORTAGE COUNTY AUDITOR TO BE ASSESSED AND COLLECTED AS TAXES FOR THE MOWING OF LOTS CONTRACTED BY THE VILLAGE OF WINDHAM TOTALING \$3400.00 AS SET FORTH HEREIN AND DECLARING AN EMERGENCY.

WHEREAS, The Council of the Village of Windham desires to collect these amounts as taxes; and

WHEREAS, the work was outsourced and paid by the Village of Windham due to owner non-compliance with Village Ordinance 555.02; and

WHEREAS, this matter is an emergency matter affecting the health, safety, and general welfare of the residents of the Village of Windham.

NOW THEREFORE, be it resolved by the Council of the Village of Windham, two thirds or more of its elected members concurs that:

Section One: The Village Fiscal Officer shall have the authority to under section 715.261 of the Ohio Revised Code to certify sums to the Portage County Auditor to be assessed and collected as taxes totaling \$3400.00 as set forth herein;

Section Three: This Resolution is hereby declared to be an emergency measure necessary to preserve the public health, safety, moral and general welfare of the inhabitants of the Village and for the further reason that the Fiscal Officer must be authorized to certify the owed amounts in this legislation to the Portage County Auditor in time for the debt to be included in the next real estate tax bill, and as a result this Resolution shall go into full force and effect immediately upon its passage by two-thirds (2/3's) or more of the members of Council.
