

ORDINANCE O-2012-24

AN ORDINANCE TO LEVY A MUNICIPAL MOTOR VEHICLE LICENSE FEE PURSUANT TO SECTION 4504.171, OHIO REVISED CODE.

WHEREAS, the Council of the Village of Windham has identified the need to increase the amount of the Motor Vehicle License Tax within the Village of Windham; and

WHEREAS, the Council of the Village of Windham has determined it is appropriate to make the recommended revisions.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Windham, County of Portage, State of Ohio, a majority or more of the members elected thereto concurring that:

SECTION I. There is hereby levied an annual license tax upon the operation of motor vehicles on the public roads or highways pursuant to § 4504.171, Ohio Revised Code, for the purposes of paying the costs and expenses of enforcing and administering the tax provided for in this section and to provide additional revenue for the purposes set forth in § 4504.06, Ohio Revised Code and to supplement revenue already available for such purposes.

SECTION II. Such tax shall be at the rate of Five Dollars (\$5.00) per motor vehicle on each and every motor vehicle the district of registration of which, as defined in §4503.10, Ohio Revised Code, is the Village of Windham, Ohio.

SECTION III. As used in this Ordinance, the term “motor vehicle” means any and all vehicles included within the definition of motor vehicle in § 4501.01 and 4505.01, Ohio Revised Code.

SECTION IV. The tax imposed by this Ordinance shall apply to and be in effect during the registration year commencing January 1, 2012, shall be first imposed upon the effective date of this Ordinance and shall continue in effect and application during each registration year thereafter.

SECTION V. The tax imposed by this Ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio or to a Deputy Registrar at the time application for registration of a motor vehicle is made as provided in § 4503.01, Ohio Revised Code.

SECTION VI. All moneys derived from the tax hereinbefore levied shall be used by the Village of Windham for the purposes specified in this Ordinance.

SECTION VII. This Ordinance shall become effective from and after the earliest date allowed by law and is not an emergency measure.
