Minutes of the Special Organizational  
Council Meeting

Held January 8, 2019

The meeting was preceded by a Public Hearing on Tuesday, January 8, 2019 at 5:45 p.m. to allow discussion of Ordinance O-2018-29 **AN ORDINANCE AMENDING THE WINDHAM VILLAGE ZONING MAP BY REPEALING THE EXISTING MAP AND AUTHORIZING AND APPROVING A NEW MAP CHANGING THE ZONING CLASSIFICATION OF 9153 MAPLE GROVE ROAD AND OF 9486 COMMUNITY DRIVE FROM THE R-2 RESIDENTIAL ZONING DISTRICT TO C-1 COMMERCIAL ZONING DISTRICT.** Those present for the Public Hearing were Cheryl Taylor, Stacy Brown, Cheryl Belknap, Sheila Moore, Phil Snyder, Larry Kulhman, Cindy Cale, Scott Garrett, Terrie Altieri, Jordan Smal, Michelle Pallo, Debbie Blewitt, and Tom Brett.
