

ORDINANCE NO. O-2007-1

AN ORDINANCE AMENDING ORDINANCE NO. O-2006-10, THE SALARIES OF ALL FULL-TIME AND PART-TIME EMPLOYEES WITHIN THE VILLAGE OF WINDHAM, COUNTY OF PORTAGE AND STATE OF OHIO, BY FIFTY CENTS (.50) PER HOUR REPEALING ALL PRIOR INCONSISTENT ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Windham employs a significant number of full-time and part-time employees within the Village; and

WHEREAS, the salaries of these employees have not had their compensation increased in some time; and

WHEREAS, the Village Council wishes to increase the salaries of the Village of Windham full-time and part-time employees by fifty cents (.50) per hour effective the 4th day of March, 2007.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Windham three-fourths or more of the members elected thereto concurring that:

Section 1: That commencing the 4th day of March, 2007 the salaries of all full-time and part-time employees of the Village of Windham shall be increased by fifty cents (.50) per hour.

Section 2: Ordinance No. 0-2006-10 is hereby amended as follows: That the compensation levels of the employees of the Village of Windham shall be increased, effective the 4th day of March, 2007 and set as follows:

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

Section 4: That this Ordinance be declared an emergency measure and become effective upon its passage by Council and approved by the Mayor, and to further insure the public health, safety and general welfare of the residents of the Village of Windham.
