

ORDINANCE O-2020-1

BEING AN ORDINANCE AUTHORIZING TRANSFERS AND APPROPRIATIONS FOR THE VILLAGE OF WINDHAM AS SET FORTH BELOW AND DECLARING AN EMERGENCY.

WHEREAS, the Mayor has recommended to Council that the following transfers and appropriations be made, and

WHEREAS, the Council of the Village of Windham declares this an emergency measure For the health, welfare and safety of the residents of the Village of Windham;


Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code:

Section 3: This Ordinance is hereby declared to be an emergency measure, immediately effective upon passage by at least two-thirds of the members elected to the Windham Village Council, in order for the Fiscal Officer to pay the current obligations of the Village in a timely fashion, and to comply with Ohio law and to establish appropriations consistent with the temporary budget used by the Village early in each fiscal year, all so as to preserve the public peace, health, or safety and general welfare of the Village of Windham.


