

**ORDINANCE O-2021-1**

**BEING AN ORDINANCE AUTHORIZING TRANSFERS AND APPROPRIATIONS FOR THE VILLAGE OF WINDHAM AS SET FORTH BELOW AND DECLARING AN EMERGENCY.**

**Section 3:** This Ordinance is hereby declared to be an emergency measure, immediately effective upon passage by at least two-thirds of the members elected to the Windham Village Council, in order for the Fiscal Officer to pay the current obligations of the Village in a timely fashion, and to comply with Ohio law and to establish appropriations consistent with the temporary budget used by the Village early in each fiscal year, all so as to preserve the public peace, health, or safety and general welfare of the Village of Windham.


