

## RESOLUTION R-2012-18

A RESOLUTION AUTHORIZING THE VILLAGE FISCAL OFFICER OF THE VILLAGE OF WINDHAM TO CREATE A THEN AND NOW PURCHASE ORDER(S) TO PAY OHIO POLICE & FIRE PENSION FUND, VICTORY WATERWORKS SUPPLY COMPANY, LLC, BURGESS & NIPLE, UNITED STATES DEPARTMENT OF AGRICULTURE AND DECLARING AN EMERGENCY.

**WHEREAS**, the Fiscal Officer of the Village of Windham has received an invoice under a contract for services or materials for which no purchase order has been attached; and

**WHEREAS**, the amount of the invoice exceeds \$3000.00; and

**WHEREAS**, the Fiscal Officer has certified that at the time of making of the contract or order for services or materials and remaining until the present that a sufficient sum has been appropriated for the purpose of such contract and that said funds are either in the treasury or in the process of collection to the credit of an appropriate fund, free from any previous encumbrances, all as required by and in conformity with Ohio Revised Code 5705.41(D); and

**WHEREAS**, the Council of the Village of Windham has determined it is appropriate to pay the amounts set forth in this Resolution.

**NOW THEREFORE**, be it resolved by the Council of the Village of Windham, County of Portage, two-thirds or more of the members elected thereto concurring that:

Section One: The Village Fiscal Officer shall have the authority to create the following Purchase Order(s)

- Number 462-2012 in the amount of \$10,273.42 to Ohio Police & Fire Pension Fund for 2012 1<sup>st</sup> Quarter Billing
- Number 472-2012 in the amount of \$7,307.56 to Ohio Edison Company for electric
- Number 477-2012 in the amount of \$9,250.00 to Victory Waterworks Supply Company, LLC for five fire hydrants
- Number 479-2012 in the amount of \$3,282.46 to Burgess & Niple for water plant improvements administration
- Number 486-2012 in the amount of \$14,508.40 to Jack Gibson Construction Company for water plant improvements
- Number 499-2012 in the amount of \$37,021.50 to United States Department of Agriculture for USDA Loans 92-03 and 92-05

Section Two: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

Section Three: This Resolution is hereby declared to be an emergency measure necessary to preserve the public health, safety, morals and general welfare of the inhabitants of the

Village and for the further reason that it is essential that the Village pay all of its financial obligations in a timely fashion, and for this reason this Resolution shall go into full force and effect immediately upon its passage by two-thirds (2/3's) of the members of Council.
