VILLAGE OF WINDHAM OHIO **ORDINANCE 0-2011-15**

AN ORDINANCE AUTHORIZING THE ADVERTISING OF BIDS FOR THE SALE OF TWO CROWN VICTORIA POLICE CARS OWNED BY THE VILLAGE OF WINDHAM IN CONFORMITY WITH OHIO REVISED CODE 721.15 AND DELARING AN EMERGENCY

WHEREAS, the Village of Windham's Police Chief has advised that in conformity with prior direction from the Village of Windham Council, he has purchased three (3) replacement Ford Crown Victoria police cruisers for use by the Village of Windham Police Department; and

WHEREAS, as a result of these purchases, the Village of Windham now has two police cruisers identified as:

Former Car 1 (Patrol Unit) 2005 Ford Crown Victoria Current approximate mileage 139,843

VIN: 2FAFP71W15X179939 Former Car 4 (K-9 Unit) 2000 Ford Crown Victoria Current approximate mileage 125,497 VIN: 2FAFP71W5YX151825

(\$1,000.00) and which are no longer needed for any municipal or public purpose; and WHEREAS, the Council of the Village of Windham has determined that it is appropriate to sell the two (2) police cruisers which are no longer needed for any public purpose.

each of which has a value determined to be in excess of One Thousand Dollars

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Windham, County of Portage, State of Ohio, two-thirds or more of the members thereto elected concurring that:

The Former Car 1 (Patrol Unit) 2005 Ford Crown Victoria, Section 1: current approximate Mileage 139,843 VIN: 2FAFP71W15X179939 Ford Crown Victoria is valued at more than One Thousand Dollars (\$1,000.00) and is no longer needed for any public purpose.

The Former Car 4 (K-9 Unit) 2000 Ford Crown Victoria current Section 2: approximate mileage 125,497 VIN: 2FAFP71W5YX151825 is valued at more than One

Thousand Dollars (\$1,000.00) and is no longer needed for any public purpose. The Windham Village Police Chief is authorized to advertise for Section 3: sale to the highest and best bidder of both the cruisers identified in Sections 1 and 2 of this Ordinance, which advertisement shall be for not less than two (2) nor more than four

(4) consecutive weeks in a newspaper in general circulation within the Village.

Section 4: The Windham Village Police Chief is authorized to sell each of the police cruisers identified in Sections 1 and 2 of this legislation to the highest and best bidder over One Thousand Dollars (\$1,000.00) each.	
Section 5: It is hereby found and determined that all actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.	
Section 6: This Resolution is hereby declared to be an emergency measure, becoming effective immediately on passage by Council and approval by the Mayor, for the reason that the funds to be realized by the sale of the police cruisers are needed to purchase other needed capital equipment within the Village of Windham Police Department.
