

RESOLUTION NO. R-2010-45

A RESOLUTION AUTHORIZING AN AGREEMENT BETWEEN THE PORTAGE COUNTY SHERIFF AND THE VILLAGE OF WINDHAM FOR A SCHOOL RESOURCE OFFICER AND DECLARING AN EMERGENCY

WHEREAS, the Village of Windham has entered into an Agreement with the Windham Exempted Village School District to provide a school resource officer to the school district; and

WHEREAS, the Village Police Department is experiencing a temporary shortage in personnel, such that it is desirable to provide for outside assistance to the Police Department in the form of a school resource officer to the Windham Exempted Village School District.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Windham, Portage County, State of Ohio, two thirds (2/3) or more of the members thereto concurring that:

SECTION 1. That the contract setting forth an Agreement between the Village of Windham and the Portage County Sheriff in substantial conformity with the agreement attached hereto and marked for identification as Exhibit "A" is hereby approved.

SECTION 2. That the actions taken by the Mayor, the Fiscal Officer and members of the Police Department of the Village of Windham in providing for a Portage County Deputy Sheriff to act as the school resource officer for the Windham Exempted Village School District in advance of the signing of the attached Exhibit "A" are hereby approved and ratified.

SECTION 3: This Resolution is declared to be an emergency measure, for the reason that the Village of Windham needs to have an agreement in place in order to assist in meeting contractual obligations to the Windham Exempted Village School District.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**AGREEMENT BETWEEN THE VILLAGE OF WINDHAM AND
THE PORTAGE COUNTY SHERIFF'S DEPARTMENT**

THIS AGREEMENT, made the ____ day of _____, 2010, between The Village of Windham, 9621 East Center Street, Windham, Ohio 44288, (hereinafter Village) and the Portage County Sheriff's Department, located at 8240 Infirmity Road, Ravenna, Ohio 44266, (hereinafter Sheriff) and is to provide for a substitute School Resource Officer (hereinafter SRO) by the Sheriff's department for the Windham Exempted Village Board of Education (hereinafter WBOE) on behalf of the Village.

WHEREAS, the Village has entered into an Agreement with the WBOE to provide for a SRO to the WBOE; and

WHEREAS, the Village has at present a temporary shortage of officers within the Village Police Department who are available to serve as SRO for the WBOE; and

WHEREAS, the Sheriff has available Deputy Sheriffs who are trained as DARE (Drug Abuse Resistance Education) officers, who can serve on a temporary basis as SRO's to the WBOE on behalf of the Village.

IT IS NOW THEREFORE AGREED:

1. The Sheriff shall provide a Deputy Sheriff, trained as a DARE Officer, to serve as a SRO to the WBOE, on behalf of the Village, for up to ten (10) hours per week on an as-needed basis. The individual selected shall be a Deputy Sheriff trained as a DARE Officer, the particular Deputy Sheriff who serves shall be selected by the Sheriff, subject to approval by the Village and the WBOE.

2. As, for and in consideration of the Sheriff providing a SRO to the WBOE in behalf of the Village, the Village agrees to pay to the Sheriff, or to another entity of Portage County but only as the Sheriff directs, the sum of Twenty Three Dollars (\$23.00) per hour, for each hour worked by a Deputy Sheriff serving on behalf of the Village as a SRO to the WBOE under this Agreement.

3. Both the Sheriff and the Village acknowledge that in the spirit of cooperation and to further the goal of providing a SRO to the WBOE for the whole of the 2010-2011 school year, that in advance of the signing of this Agreement, the Sheriff has already provided Deputy Sheriffs who have in the past and will continue to serve, up to ten (10) hours per week, as the SRO on behalf of the Village to the WBOE. The actions of the Sheriff in providing this service are acknowledged and approved by the Village. Further the Village acknowledges, approves, and ratifies the actions of the Village administration in requesting and obtaining this service, and authorizes payment and compensation to the Sheriff in the amount of Twenty Three Dollars (\$23.00) per hour for each hour of SRO service provided to date.
