

RESOLUTION R-2019-7

A RESOLUTION AUTHORIZING A CONTRACT WITH CENTRAL PAINTING & SANDBLASTING, INC. FOR THE WINDHAM WATER TOWER PAINTING PROJECT WITHIN THE VILLAGE OF WINDHAM, PORTAGE COUNTY, OHIO AND DECLARING AN EMERGENCY

WHEREAS, the Village of Windham has previously advertised for bids for the Windham Water Tower Painting Project of the Village of Windham; and

WHEREAS, the first time the Village advertised for bids to perform the Windham Water Tower Painting Project no bids were received; and

WHEREAS, advertisements were made a second time, and in The Youngstown Vindicator, a newspaper of general circulation within the Village of Windham, on September 15, 2018, September 22, 2018 and September 29, 2018, that sealed bids for the Windham Water Tower Painting Project would be received at the Village Fiscal Officer's office at 9083 N. Main Street within the Village of Windham until 2:00 p.m. on October 5, 2018; and

WHEREAS, one sealed bid was received by the Village of Windham; and

WHEREAS, the sealed bid from Central Painting & Sandblasting, Inc. in the amount of Two Hundred Thirty Nine Thousand Dollars & 00/100 (\$239,000.00) is less than the Village Engineer estimate and is the lowest and best bid that has been received; and

WHEREAS, the Village Administrator of the Village of Windham has checked the references of Central Painting & Sandblasting, Inc., and has found that the references demonstrate that Central Painting & Sandblasting, Inc. to be a responsible and responsive company, capable of performing under the contract if the contract is awarded to them; and

WHEREAS, the Village Administrator has recommended that Central Painting & Sandblasting, Inc. has submitted the lowest and best bid which is a responsive and responsible bid and that the Windham Water Tower Painting Project contract be awarded to Central Painting & Sandblasting, Inc.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Windham, State of Ohio, two thirds or more of the members thereto concurring that:

Section 1: That the recommendation of the Village Administrator is hereby accepted.

Section 2: That the bid submitted by Central Painting & Sandblasting, Inc. is declared to be the lowest and best bid.

Section 3: That a contract, in substantial conformity with that attached hereto and marked for identification as Exhibit "A" between Central Painting & Sandblasting, Inc. and the Village of Windham, is hereby authorized. The Village Administrator and the Fiscal Officer are directed to execute said contract.

Section 4: The Village Council finds that the procedure followed by the Village administration in awarding the Windham Water Tower Painting Project contract to Central Painting & Sandblasting, Inc. complies with Ohio Revised Code 731.141.

Section 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

Section 6: This Resolution is hereby declared to be an emergency measure, becoming effective immediately on passage by Council and approval by the Mayor, in order to advance the

health, safety and general welfare of the Village of Windham, and for the further reason that it is necessary to begin the Windham Water Tower Painting Project in the Village of Windham at the earliest possible time so as to comply with the time requirements of the Ohio Public Works Commission Grant awarded to the Village for this project.
