

ORDINANCE NO. O-2008-1

AN ORDINANCE AMENDING ORDINANCE NO. 0-2007-1, TO REFLECT THE CURRENT SALARIES AND WAGES OF ALL FULL-TIME AND PART-TIME EMPLOYEES WITHIN THE VILLAGE OF WINDHAM, COUNTY OF PORTAGE AND STATE OF OHIO, REPEALING ALL PRIOR INCONSISTENT ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Windham employs a significant number of full-time and part-time employees within the Village; and

WHEREAS, the salaries of these employees have been modified by various ordinances over the past year; and

WHEREAS, the Village Council wishes to set forth the salaries and wages of the Village of Windham full-time and part-time employees that are in effect as of this date;

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Windham three-fourths or more of the members elected thereto concurring that:

Section 1: Ordinance No. 0-2007-1 is hereby amended as follows: That the compensation levels of the employees of the Village of Windham are set as follows:

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

Section 3: That this Ordinance be declared an emergency measure and become effective upon its passage by Council and approved by the Mayor, and to further insure the public health, safety and general welfare of the residents of the Village of Windham.
