

RESOLUTION R-2020-18

A RESOLUTION FIXING THE TIME AND PLACE OF THE PUBLIC HEARING ON THE PROPOSED AMENDMENTS TO THE WINDHAM VILLAGE ZONING CODE AND DECLARING AN EMERGENCY.

Whereas, the Village of Windham Zoning Inspector has recommended a change to the \Windham Village Zoning Code; and

Whereas, the Village of Windham Planning Commission is expected to consider the proposed amendment to the Village of Windham Zoning Code at its next meeting, presently scheduled for September 8, 2020; and

Whereas, in conformity with the Windham Codified Ordinance § 1147.01, Council, by resolution, must fix the time and place of the public hearing on the proposed amendments, and publish the notices of the public hearing on the amendments.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Windham, Portage County, Ohio, two thirds (2/3) or more of its members concurring:

SECTION 1: That, the public hearing via Zoom on the proposed amendments to the Village of Windham Zoning Code shall be held on October 13, 2020 beginning at 5:30 p.m. and shall be open to all members of the public who contact the Village Administrative Assistant, Elizabeth Derthick, to obtain access to the Zoom public hearing.

SECTION 2: That the Village Fiscal Officer is directed to cause notice of the proposed zoning code amendments and the time and place of the public hearing to be published in the Record Courier, a newspaper of general circulation within the Village, once a week for three consecutive weeks, with the first publication appearing at least thirty (30) days before the public hearing.

SECTION 3: That, in accordance with Windham Codified Ordinance § 1147.01(b)(4), the Village Fiscal Officer is directed to cause such notice to be sent to every association of Village residents that have registered its name and address for this purpose with the Fiscal Officer.

SECTION 4: This Resolution is declared to be an emergency measure effective immediately upon its passage by Council and approval by the Mayor, for the reason that hearing on the proposed amendment to the Zoning Code of the Village of Windham must be held to establish consistent treatment of fences within the Village of Windham as soon as possible.

SECTION 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were accepted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with Section 121.22 of the Ohio Revised Code.


